If you select both AM and PM Extended Care, the additional charge will be \$14 per child per day.

**STANDARD CONDITIONS OF ENROLLMENT**

1. A deposit of \$650 per child and a signed camper enrollment form are required to complete registration. (Registration after February 1, 2010 requires a deposit of \$1400 per child to include the second payment).
2. The tuition fee includes transportation and all camp activities except horseback riding and trips (exclusive of CIT Day Trips), which are optional. If transportation is provided by a parent, there is no reduction of tuition.
3. Your full deposit less a \$100 administrative fee is refundable on or before March 1, 2010. As of April 1, 2010 there is no refund of your \$650 deposit.
4. A second payment of \$750 per child is due by January 31, 2010
5. All tuition monies must be paid in full by May 15, 2010. The person signing this contract assumes full responsibility for the full payment of tuition. Non-payment by May 15, 2010 will result in loss of any Early Bird or other discounts.
6. Any camper whose tuition is not paid in full by May 15, 2010 will be considered “out of camp” and their enrollment will be canceled for non-payment. There will be no refund of any monies paid, including deposit.
7. After March 1, 2010, there will be no refund of any tuition for any camper who does not attend camp for non-medical reasons.
8. Daily absences will not be refunded or made up.
9. Tuition rates for extensions after May 15, 2010, will be calculated on the tuition schedule for the cycle following the one you originally signed up for (see tuition schedule). For example, if you signed up during “Cycle 2” and add additional weeks, they will be calculated based on “Cycle 3” rates.
10. Tuition refunds for week reductions, after May 1, 2010, will be calculated on the tuition schedule for the cycle following the one you originally signed up for (see tuition schedule). For example, if you signed up during “Cycle 2” and reduce the number of weeks, the refund will be calculated based on “Cycle 3” rates. A refund of tuition less the cost of the required four week tuition rate will be made.
11. Refunds will not be made before 30 days after cancellation is received in writing.
12. A \$35 service fee will be charged for all returned checks.
13. Changes in enrollment dates can be made only if the camp is notified at least 1 week in advance. Changes in week 1 enrollment cannot be made after June 1, 2010.
14. All weeks are Monday through Friday. There are no split weeks.
15. Mill Road Day Camp assumes no responsibility for lost, misplaced or stolen items.
16. The camper, his or her parents, guardians, etc., agree to abide by the rules and regulations set by Mill Road Day Camp for the health, safety and welfare of the campers, the staff and the camp. Camp reserves the right to dismiss a camper without refund if conduct is detrimental to the well being of the camper or other campers. There are no refunds for suspensions or dismissal.
17. I understand that Mill Road requires each camper to have a completed medical form and immunization history on file prior to their arrival in camp.
18. I give permission for the medical personnel selected by the camp to provide routine health care and to administer medication. Further, I give permission for medical personnel or hospital to treat my child in an emergency situation.
19. I give permission for my child to participate in all camp activities and to go off campus on camp trips, for rainy day and inter-camp activities.
20. I give permission for Mill Road Day Camp to use any and all photographs and videos taken of my child for display, publicity and advertising purposes. The use of these photographs and videos is unrestricted and without reimbursement and they remain the property of Mill Road Day Camp..
21. Mill Road Day Camp reserves the right to terminate this contract at any time and for any reason.
